Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equate to .53 tCO $_2$ e, a **1.69**%ge reduction against the 2050 baseline and the measures will be in effect when performing the contract.

To achieve this, we have encouraged more car sharing amongst our employees, this includes not only our office staff to and from the office, but also our engineers and sales team.

During the colder months of the year, we have reduced the number of electrical heaters that are used within the office, and also made it mandatory that they are turned off overnight and only used as and when necessary, with employees being encouraged to wear more layers.



We have also tried to ensure that the waste from our business is more effectively disposed of, repurposed or re-sold to reduce its effect on the environment.

In the future we hope to implement further measures such as:

- Continuing to ensure that we monitor and reduce our emissions and carbon footprint even more so over the coming years.
- Employees that require company provided vehicles to carry out their jobs will be encouraged to take on Electric Vehicles. Alongside this we will also encourage working from home more often.
- The office is almost completely paperless and we will continue to reduce our use of paper in the future.
